About this document

This document is an updated version of the AMSA annual regulatory plan 2016-17 that was published in August 2016.

Purpose of an annual regulatory plan

AMSA publishes regulatory plans to provide business and the community with information about planned changes to regulatory instruments, such as Marine Orders and the National Standard for Commercial Vessels (NSCV), to make it easier for business and the community to take part in the development of those instruments that are likely to affect them.

AMSA regulatory instruments are available from the AMSA website at: <u>www.amsa.gov.au</u>.

AMSA publishes an annual regulatory plan early in each financial year and may publish revised annual regulatory plans during the year when appropriate. The regulatory plans contain information on:

- details of legislative or other action planned for the current financial year that could lead to changes in business regulation; and
- changes to business regulation that occurred during the previous financial year.

Information provided in regulatory plans is correct at the time of publication. While there may be some regulatory activities that AMSA is unable to forecast, these activities will involve consultation with affected parties and will be recorded in future regulatory plans.

Consultation

The objective of consultation is to solicit comment from affected parties on the proposed changes to regulatory instruments, including any information on costs and benefits.

Consultation is open to the public and all documentation will be made available online with relevant contact details. Specific stakeholder forums may also be planned.

1. Planned Regulatory Actions

Marine Order 9 (Health - medical fitness) 2010	
Description of Action	Review and replace the Order as Marine Order 76 under the <i>Navigation Act 2012</i> and modernise the drafting style. Consequential amendments will be made via Marine Order 80 to Marine Orders 2, 54, 70, 71, 72, 73 and 74, which reference the certificate of medical fitness. Supporting guidance material will also accompany the Order.
Consultation	Public consultation is planned to occur in May 2017.
Date of Effect	Proposed: 1 August 2017.

Marine Order 31 (Vessel surveys and certification) 2015	
Description of Action	Amendments to clarify and incorporate the existing survey and certification requirements for government vessels (currently in Marine Order 62). It is proposed to change the application to government vessels from not more than 7 metres to not more than 10 metres in length. These amendments will be included in Marine Order 82.
Consultation	Public consultation is planned to occur in June 2017.
Date of Effect	Proposed: 1 September 2017.

Marine Order 41 (Carriage of dangerous goods) 2009	
Description of Action	Review and reissue the Order under the <i>Navigation Act 2012</i> and modernise the drafting style. Replace schedule 21 of Marine Order 4.
Consultation	Public consultation is planned to occur in May 2017.
Date of Effect	Proposed: 1 August 2017.

Marine Order 43 (Cargo and cargo handling - livestock) 2006	
Description of Action	Review and reissue the Order under the <i>Navigation Act 2012</i> and modernise the drafting style. Replace schedule 23 of Marine Order 4.
Consultation	Public consultation is planned to occur in September 2017.
Date of Effect	Proposed: 1 January 2018.

Marine Order 44 (Safe containers) 2002	
Description of Action	Review and reissue the Order under the <i>Navigation Act 2012</i> and modernise the drafting style. Replace schedule 24 of Marine Order 4.
Consultation	Public consultation is planned to occur in September 2017.
Date of Effect	Proposed: 1 January 2018.

Marine Order 51 (Fishing vessels) 1989	
Description of Action	Review and incorporate existing fishing vessel qualifications under the <i>Navigation Act 2012</i> into Marine Order 71.
Consultation	Public consultation is planned to occur in October 2017.
Date of Effect	Proposed: 1 January 2018.

Marine Order 59 (Offshore support vessel operations) 2011	
Description of Action	This Order will be repealed.
Consultation	Initial public consultation occurred in August 2014. Further public consultation is planned to occur in March 2017.
Date of Effect	Proposed: 1 July 2017.

Marine Order 72 (Engineer officers) 2014	
Description of Action	Amendment to clarify electro-technical officer prerequisite, add a list of electrical trades, add definitions, and provide clarity on certification and combination of sea time.
Consultation	Public consultation is planned to occur in April 2017.
Date of Effect	Proposed: 1 July 2017.

Marine Order 82 (Miscellaneous amendment) 2017	
Description of Action	Minor administrative and editorial amendments to Marine Orders 12, 25, 32, 34, 54 and 74 to improve the clarity and operation of those Orders.
Consultation	Public consultation is planned to occur in May 2017.
Date of Effect	Proposed: 1 July 2017.

Marine Order 83 (Amendment for Polar Code environment measures) 2017	
Description of Action	This Order will amend Marine Orders 91 and 96, which require minor amendments for the International Code for Ships Operating in Polar Waters (Polar Code). The timing of this work is subject to the amendments to the <i>Protection of the Sea (Prevention of Pollution from</i> <i>Ships) Act 1983.</i>
Consultation	Public consultation is planned to occur in June 2017.
Date of Effect	Proposed: 1 September 2017.

Marine Order 97 (Marine pollution prevention - air pollution) 2013	
Description of Action	Amendments to give effect to changes in regulation 13 of Annex VI of the International Convention for the Prevention of Pollution from Ships (MARPOL) for record requirements for operational compliance with NOx Tier III emission control areas (International Maritime Organization Resolution MEPC.271(69)).
Consultation	Public consultation is planned to occur in June 2017.
Date of Effect	Proposed: 1 September 2017.

Marine Order 502 (Vessel identifiers - national law) 2013	
Description of Action	Amendments to rationalise and simplify the requirements relating to obtaining and displaying a unique vessel identifier.
Consultation	Public consultation is planned to occur in April 2017.
Date of Effect	Proposed: 31 May 2017.

Marine Order 503 (Certificates of survey - national law) 2013	
Description of Action	Amendments to provide greater clarity around when an 'existing vessel' will become a 'new vessel' under the Order. It will also provide greater flexibility around the standards that can be applied once an 'existing vessel' becomes a 'new vessel'.
Consultation	Public consultation is planned to occur in April 2017.
Date of Effect	Proposed: 1 July 2017.

Marine Order 503 (Certificates of survey - national law) 2013	
Description of Action	Amendment to incorporate the survey requirements for domestic commercial vessels that are currently located in section 4 of the National Standard for Administration of Marine Safety (NSAMS). This is a major red tape reduction measure, significantly reducing the burden imposed by the NSAMS survey regime requirements. The requirements are being reviewed in response to the <u>2014 Streamlining Review</u> (see streamlining concepts 5, 7 and 8). A Regulation Impact Statement is being developed for this proposal.
Consultation	Public consultation occurred in August 2015. Further public consultation is planned to occur in June 2017.
Date of Effect	Proposed: 1 July 2018.

Marine Order 504 (Certificates of operation - national law) 2013	
Description of Action	Amendment to address a number of the issues identified during the Operation Safety Review, which will ultimately simplify and rationalise operational requirements for domestic commercial vessel operators.
Consultation	Public consultation is planned to occur in April 2017.
Date of Effect	Proposed: 30 June 2017.

Marine Order 505 (Certificates of competency - national law) 2013	
Description of Action	Consequential amendments arising from the repeal of Marine Order 506.
Consultation	Public consultation is planned to occur in March 2017.
Date of Effect	Proposed: 1 May 2017.

Marine Order 506 (Approval of training organisations - national law) 2013	
Description of Action	This Order will be repealed.
Consultation	Public consultation is planned to occur in March 2017.
Date of Effect	Proposed: 1 May 2017.

Marine Order 507 (Load line certificates - national law) 2013	
Description of Action	Amendment to provide the technical specifications for all vessels over 24m in length that will need to comply with Loadline requirements.
Consultation	Public consultation is planned to occur in May 2017.
Date of Effect	Proposed: 1 July 2017.

NSCV Part C2 - Watertight and weathertight integrity	
Description of Action	Amendment to establish required outcomes for watertight and weathertight integrity.
Consultation	Public consultation is planned to occur in April 2017.
Date of Effect	Proposed: 1 June 2017.

NSCV Part C4 - Design and Construction - Fire Safety	
Description of Action	Amendments to implement the outcomes of the review of NSCV Part C4 undertaken by Lloyds Register in 2014/2015. It will address a number of technical and workability issues with the standard that have been identified and improve the overall readability of the standard.
Consultation	Public consultation is planned to occur in May 2017.
Date of Effect	Proposed: 1 September 2017.

NSCV Part C5A - Design and Construction - Engineering - Machinery	
Description of Action	Amendment to address technical or practical workability issues with current requirements.
Consultation	Public consultation is planned to occur in April 2017.
Date of Effect	Proposed: 30 June 2017.

NSCV Part C7A - Design and Construction - Equipment - Safety Equipment	
Description of Action	Amendments to introduce transitional requirements that will require new and existing vessels to comply with the NSCV Part C7A by 1 January 2018.
Consultation	Public consultation is planned to occur in June 2017.
Date of Effect	Proposed: 1 January 2018.

NSCV Part F1A - Fast Craft - General Requirements for Fast Craft	
Description of Action	Amendment to address technical or practical workability issues with current requirements.

Description of Action	Amendment to address technical or practical workability issues with current requirements.

Description of Action	Amendment to incorporate technical content for vessel design, construction and equipment standards, provide industry with greater flexibility in meeting some requirements, rationalise requirements relating to the carriage of equipment, and restructure and co-locate requirements to improve overall readability and assist industry understanding of requirements.
Consultation	Public consultation occurred in August 2016.
Date of Effect	Proposed: 1 April 2017.

Description of Action	Implement SOLAS Chapter XIV for the Polar Code.
Date of Effect	1 January 2017.

Description of Action	Review and reissue the Order under the <i>Navigation Act 2012</i> and modernise the drafting style. Replace schedule 33 of Marine Order 4.
