- c. by a trustee or official receiver or other person in whom the interest claimed by the caveator is vested pursuant to the *Bankruptcy Act 1966*; or
- d. by any person in whom there is entrusted, by reason of the mental capacity of the caveator, pursuant to an order of a court of a State or Territory or pursuant to a law of a State or Territory, the management and care of the interest claimed by the caveator.
