Amendment No 2 to the

National Standard for Commercial Vessels Part C; Design and Construction Section 7; Equipment Subsection 7A; Safety Equipment (Edition 1 as amended by Amendment No 1)

Revised Text

Edition 1 of the National Standard for Commercial Vessels, Part C; Design and Construction, Section 7; Equipment, Subsection 7A; Safety Equipment as published on the web in October 2004, and on CD in April 2005 and as amended by Amendment 1 dated November 2005, is amended as follows.

The amendment was approved by the National Marine Safety Committee on 2 April 2008 and published on 2 July 2008 for information purposes only, pending final ATC endorsement. The amendment was endorsed by the ATC on 7 November 2008 and comes into effect from that date.
